



2025 Financial Statements - Comments from the Foundation

The Jordan Boyd Foundation is a not-for-profit society registered in Nova Scotia and is guided by a board of volunteer directors. Since 2013, through donations and fundraising initiatives the Foundation has raised funds to conduct its work.

The Jordan Boyd Foundation has been established with following goals:

- To educate and raise awareness of inherited heart diseases in young people and particularly athletes and to support research and investigation into same, including early detection and cures. Our primary partner in this activity is the QEII Foundation and the Inherited Heart Disease Clinic at the QEII Hospital in Halifax.
- To support education and awareness of CPR and AED's (Automatic External defibrillators) and funding of same for public spaces and not-for-profit organizations.

The financial statements for 2025 reflect funds received and expenditures made directly through the Foundation. They also note funds on hand and invested.

In 2025 revenues include general and specific donations as well as gains (losses) on invested funds; while expenditures are primarily related to the donation of portable Automated External Defibrillators (AED's) for an initiative with Atlantic University Sports to improve their safety planning and program to protect varsity athletes and the greater university communities in the event of a sudden cardiac arrest; and advocacy and AED donations to improve AED access for public spaces and not for profit community organizations in partnership with Emergency Health Services Nova Scotia (EHS).

The Foundation has committed \$50,000 in 2026 to continue AED initiatives in a joint venture with the Heart & Stroke Foundation and EHS Nova Scotia.
